Marika Djolai (PhD, University of Sussex) is currently a Lecturer in Peace Studies and International Development at the University of Bradford. Her previous role was Senior Researcher and Head of Conflict and Security Cluster at the European Centre for Minority Issues. Dr Djolai holds a PhD in Development Studies awarded in June 2016 for the thesis called 'When the Rooftops Became red Again: Post War Community Dynamics in Bosnia and Herzegovina'.
